

FRIENDS CAMP GENERAL INFORMATION AND APPLICATION

Friends Camp is a small Quaker (Friends) youth camp located on China Lake in South China, Maine. The focus, policies, annual budget, and, program direction of the camp are under the care of a fifteen member Camp Committee that is appointed by the New England Yearly Meeting of Friends.

Friends Camp offers a unique summer experience for young adults. The goal of each session is to build a community. In a loving and caring atmosphere, the staff plan activities, work together, and implement interesting and creative recreational programs. Daily Meetings for Business helps us to determine the needs of all, and consensus is the process used for decision-making. We also meet daily for Meeting for Worship and for evening vespers. Friends Camp staff members and youth campers come from diverse religious, geographic, racial, and economic backgrounds. While it is not a requirement for a staff member to be a Quaker, we do ask staff to be comfortable Quakerism and with the five values that are the foundation of the programming and activities at Friends Camp:

- *We are a youth camp with a unique atmosphere of tolerance and love where special friendships develop.*
- *All members of our camp community try to see the light of goodness in everyone.*
- *We practice the Quaker values of community, equality, integrity, peace, & simplicity.*
- *Our interesting, creative, non-competitive and fun activities help young people grow into healthy and responsible adults.*
- *We seek socio-economic diversity by providing affordable tuition and camperships.*

It is not our practice to preach Quakerism/Christianity, but to live the principles that represent the Quaker values.

WHO SHOULD APPLY?

There are some guidelines. Counselors should be at least 19 years old or have completed one year of college. Water Safety Instructors, Outdoor Camping Director, Drivers, and Nurse or Emergency Medical Technician (EMT's) or Wilderness First Responder (WFR's) should be at least 21 years old. We look for individuals with a variety of skills and talents. Each counselor should be willing to teach and learn from other counselors. Counselors also need to be highly creative and contribute to all programs, regardless of specialty. By moving from one program area to another, day by day, we hope to prevent mundane programs and maintain a fresh approach. Some of the positions at Friends Camp are Counselors/Activity Leader, EMT's/WFR's or Nurse, Water Safety Instructor, Crafts Director, Drama Director, Superman, and Wonder Woman.

HOW TO APPLY

To apply, send your application to the director and distribute the three references forms to your employers and/or professors. Please no peer or relative references. If qualified, the director will interview you by phone or in person. OTHER QUALIFICATIONS

We need people who can be fully committed to the responsibilities of the job being camp counselor. Honesty is high on our list and we are looking for maturity and willingness to give and take directions. Please remember that issues concerning your career, politics, finances, social relationships, and any personal problems need to take a secondary position while you are working at Friends Camp. Being a counselor can be hard at times but it is also very rewarding and important work.

ORIENTATION WEEK

It is time to 'build our family', learn about the camp, learn about the needs of campers, prepare the site, and program areas. We will share skills, learn from one another, develop the program, and review policies. This year orientation week begins Sunday, June 19, 2011 at 11:45 AM. The period of employment for most staff members is from June 19th to August 21st or if you are working during Family Camp, your end date will be August 27th. We have First Aid/CPR class from 8:45 AM to 4:15 PM on June 18th and our lifeguard program will start at 8:45 AM on June 14th.

GENERAL RESPONSIBILITIES:

1. Leadership and guidance of cabin group and program groups for youth between the ages of 7 and 17.
2. Lead and teach small and large group activities.
3. To be an excellent role model with high moral and ethical standards for all campers and staff members.

SPECIFIC RESPONSIBILITIES

1. Live with small group of campers and help each camper adjust and grow in relation to other campers and camp life; and monitor daily hygiene of each camper.
2. Work cooperatively as necessary with all other staff members in planning, implementation, and evaluation of the program.
3. To interpret philosophy, rules and regulations of the camp, with special emphasis on safety and health regulations for the campers.
4. Guide each individual camper in their participation in small group activities and if need help them get involved with the large group activities. Assist campers in choosing and scheduling their activities.
5. Assist with all camp program activities and other camp wide activities as assigned.
6. Act as host at tables in dining room and lead work cleanups responsibility.
7. Attend, lead, and participate in meeting for worship.
8. Attend staff meetings regularly and relay information to other staff not present. Contribute as necessary.
9. Set an overall good example for all, other staff, and campers.
10. Prepare written evaluation at the end of the summer following the guidelines provided by the Director.
